In consideration of permission to use, today and on all future dates, the property, facilities, equipment, and services of **Isaiah 58 Skate House**, (hereafter known as "**Isaiah 58 Skate House**", it's owners, affiliates, directors, officers, employees, agents, insurers, landowner, landlords of the facilities or equipment, and all of their successor's and assigns. I, the undersigned (skater or spectator) hereby expressly agree.

1. THAT roller skating is a participation sport and I am fully aware of the risks and hazards involved in or arising from my use or presence upon the facilities. I HEREBY ASSUME ANY AND ALL RISKS INVOLVED IN OR ARISING FROM MY USE OF OR PRESENCE UPON THE FACILITIES, including without limitation the risks of bodily injury resulting from collision between myself and another person or a stationary object or the negligent or deliberate act of another person.

2. TO RELEASE "**Isaiah 58 Skate House**", it's owners, affiliates, directors, officers, employees, agents, insurers, landowner, landlords of the facilities or equipment, Skaters Pro-Shop, from and AGREES NOT TO SUE ANY OR ALL OF THEM on account of or in connection with any claims, causes of action, injuries, damages, cost or expenses arising out of skater's use of or presence upon the facilities or use of "**Isaiah 58 Skate House**" skates or equipment, including but not limited to those claims for bodily injury whether or not caused by the negligence or other fault of "**Isaiah 58 Skate House**".

3. THAT I HAVE NO pre-existing medical or physical issues nor am I under any medical treatment for any injury or other condition that precludes me from participating safely or would be aggravated by my participation in the sport of roller-skating.

4. TO FOLLOW THE POSTED RULES OF THE FACILITY and instructions from the skate floor guards and supervisors. If I see any of the following activities I will stop skating, notify management immediately and will not resume skating until the matter has been resolved: (1) debris, water, soda, candy or other substances on the rink surface, skate floor or anywhere in the building or if I see anyone bring these items onto the rink surface.

(2) Skaters engaging in reckless skating, backwards skating (prohibited during public all age sessions) or skating in the wrong direction (except specialty skate). (3) Any other dangerous activity or condition.

5. IF I IGNORE THIS AGREEMENT AND FILE SUIT, I WILL BE HELD RESPONSIBLE FOR ALL LEGAL FEES and court costs incurred by "**Isaiah 58 Skate House**" and agree TO INDEMNIFY "**Isaiah 58 Skate House**" and", it's owners, affiliates, directors, officers, employees, agents, insurers, landowner, landlords of the facilities or equipment, Skaters Pro-Shop, and all of their successor's and assigns including counseling fees, for any losses to themselves or anyone else arising out of MY use of the facility.

### RULES OF THE FACILITY

- No chewing gum anywhere in the facility
- Change shoes and skates in the locker area
- All persons renting skates will be required to wear socks
- For your safety and security, lock all coats, shoes and purses in lockers. We are not responsible for lost or stolen articles.
- Toe stops or plugs must be worn on all skates that have a place for toe stops.
- No sitting on the walls, counters, or table tops anywhere in the facility.
- All food and beverages must be kept in the concession or party seating areas.
- No food or beverages, including alcoholic beverages, may be brought into the facility.
- While skating: No pushing, playing tag, chain skating, or stopping at any time on the skate floor.
- Hats and head scarves are not permitted to be worn on the skate floor.
- Cell phones, mp3 players, cameras or other hand held loose objects are not allowed on the skate floor while skating.
- Reckless or inconsiderate skating will not be tolerated.
- Anyone wearing skates is not permitted to carry a child.
- If you are pregnant or have a serious medical condition that may be aggravated by exercise, please do not skate.
- Profanity or foul language is not permitted.
- We reserve the right to check all bags. (Entering and Exiting)
- Before leaving, please tuck the laces inside the skates and place the skates on the rental counter.
- All skaters must complete and sign a skate waiver.
